# Directions to SEMCOG

## Driving Directions

### From the north:

**Southbound I-75:** (Westbound I-94 will connect you to I-75)

Take I-75 south to I-375, follow I-375 south to the Civic Center and onto westbound Jefferson Ave. Turn right onto Griswold St. (one block past Woodward Ave.); the Buhl Building is on the left.

**Southbound Lodge (M-10):** Take the Lodge south to exit 1B on the left onto W. Larned St. toward Cobo Center. Take Larned St. three blocks to the to Griswold/Larned Parking garage, which will be on your left.

### From the south:

**I-75 is closed in both directions between Clark and I-96.**

Take I-75 north to Livernois Avenue exit and turn right to Fort Street east, or  
Take I-275 north to I-94 east to M-10 south.

### From the west:

Eastbound I-94 will connect you to the Lodge.

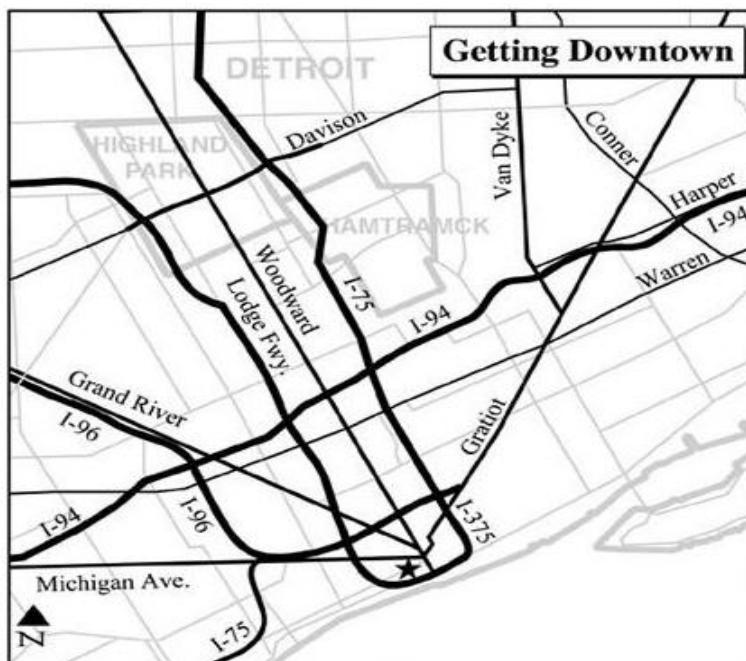
Eastbound I-96 connects to the I-75 Civic Center ramp; follow the Civic Center exit onto the southbound Lodge.

**Eastbound as Westbound I-96 from I-94 to I-75 will be closed starting July 14, 2008 to October 9, 2008**

## Transit Options

The Buhl Building is located one block north of the [Detroit People Mover's](#) Financial District stop, and is located near several downtown bus stops served by [DDOT](#) and [SMART](#) lines.
