## MMLWCF Loss Control Achievement Awards

Twenty-eight Michigan communities have earned statewide honors for their outstanding efforts in maintaining safe work environments.

The Michigan Municipal League Workers' Compensation Fund has issued its annual Loss Control Achievement Awards for 2010 to the communities listed below. The certificates were mailed October 22, 2010.

The awards are based on a community's Experience Modification Factor (EMF) rating, using a formula measuring the frequency and severity of employee injuries over a 3.5-year time period. The average EMF is 1.00. Any Fund member with an EMF under 1.00 saves significant premium dollars.
