CHAPTER 7-05

VEHICLES ON SCHOOL PROPERTY

7-05.01 Purpose

The operation, parking, and speed of vehicles on school property shall be regulated.

7-05.02 Speed Limit

- .01 Reasonable and Proper Operation. Any person operating a motor vehicle on property of a Board of Education in the City shall operate the same at a careful, prudent speed not greater than nor less than is reasonable and proper, having due regard to the traffic, the surface and width of the traffic lane in which said vehicle is traveling and of any other conditions then existing.
- .02 Ability to Stop. In no event shall any such person operate a motor vehicle on said properties at a speed greater than that which will permit him to bring said vehicle to a stop within an assured clear distance ahead.
- .03 Maximum Unposted Speed. Provided, further, that in no event shall the speed of any vehicle operated on such properties exceed 15 miles per hour, unless otherwise posted.

7-05.03 Parking

- .01 Spaces Marked. The Boards of Education having jurisdiction in the City of Rochester Hills shall cause lines or marks to be painted on the surface of the parking areas located on their respective properties within the City of Rochester Hills to designate the spaces to be used for vehicular parking thereon.
- .02 Illegally Across Lines. On said property which is so marked, it shall be unlawful to park any vehicle across any such lines or marks, or to park any vehicle in such a way that the same shall not be within the area so designated by such lines or markings unless such vehicle is too large to be confined in one such space.
- .03 <u>In Prohibited Areas.</u> No person shall park, stand or stop a motor vehicle where official signs prohibit parking, standing or stopping, except
 - A. As Directed by Officer. In compliance with the di-

- rections of a City of Rochester Hills Police Officer or the Oakland County Sheriff or his deputy at any place upon the property of a Board of Education.
- B. Designated Areas. In instances where parking is not adequate for specific events such as a football game or a baseball game, there may be parking in areas designated by school authorities for additional parking, so long as the additional areas are clearly marked for parking and/or school personnel direct cars to the additional parking areas.
- .04 Time Limit. It shall be unlawful to park any motor vehicle on any property of a Board of Education in the City of Rochester Hills for a period longer than one (1) hour between the hours of 8:00 A.M. to 5:00 P.M. Monday through Friday unless:
 - A. Signs. Otherwise provided by signs erected and maintained by a Board of Education giving notice of such exception.
 - B. Permission Stickers. Provided, however, that this prohibition shall not apply to vehicles which display on their windshields a sticker or emblem issued by this Board of Education upon whose property the vehicle is parked, giving permission to the operator of said vehicle to park such vehicle for longer periods of time.
- 7-05.04 Enforcement (Amended by Ordinance No. 142, effective February 10, 1983)
 - Chapter pertaining to standing or parking of vehicles are hereby declared to be civil infractions as provided for in the Michigan Motor Vehicle Code and Chapter 7-11 of the Code of Ordinances. The procedure for issuing of Parking Violation Notices or Appearance Citations, the procedure after their issuance, fines to be assessed and all other provisions relating to violations of standing or parking provisions of this Chapter shall be in accordance with and pursuant to Chapter 7-11 of the Code of Ordinances, which Chapter is incorporated herein by reference.
 - .02 Other Violations. For violations other than parking, standing, and stopping, this Chapter shall be enforced only by any Deputy Sheriff of the Oakland County Sheriff's Department, or any Michigan State Police Officer.

7-05.05 Towing

- .01 Authority Granted. The police of the City of Rochester Hills and the Oakland County Sheriff's Department are hereby authorized to remove and tow away, or have removed and towed away by a commercial towing service, any car or other vehicle parked in violation of this Chapter where such parked vehicle
 - (A) Creates or constitutes a traffic hazard,
 - (B) Blocks the use of a fire hydrant,
 - (C) Obstructs or may obstruct the movement of any emergency vehicle.
- .02 Impounding. Cars so towed away for illegal parking shall be stored in a safe place.
- .03 Payment of Fine and Charges. Cars so towed away for illegal parking shall be restored to the owner or operator of such car upon payment of the fine as provided in sub-section 7-05.04.01 and the reasonable towing and storage charges.

CHAPTER 7-06

TRAFFIC CONTROL IN SHOPPING CENTER PARKING LOTS

7-06.01 <u>Purpose</u>

Traffic in shopping center parking areas shall be regulated, an authorized representative of each of the shopping centers specified in this Chapter having requested in writing this regulation at each of the named shopping centers. (Amended by Ordinance No. 208, effective August 7, 1987)

7-06.02 Unlawful Standing or Parking

At any time it shall be unlawful for any vehicle to stand or to park in any of the following areas:

- North Hill Shopping Center. Any marked entrance and/or exit lanes and marked driving aisles, in the parking lot of the shopping center commonly known as the North Hill Shopping Center, which is located in the southwest quadrant of the intersection of Rochester Road and Tienken Road. This area shall specifically include the entire area thirty (30) feet from the curb in front of the entire length of the buildings comprising the stores and shops of the North Hill Shopping Center. (Amended by Ordinance No. 208, effective August 7, 1987)
- Rochester Hills Plaza. The marked entrance and exit lanes, and the marked aisles in the parking lot of the shopping center which is commonly known as the Rochester Hills Plaza, which is located north of Walton Boulevard, west of the centerline of Livernois Road approximately seven hundred thirty-one (731) feet. This area shall specifically include the area adjoining the buildings in the Rochester Hills Plaza, extending from the curbs in front of said buildings to the area marked for parking spaces. (Amended 3-20-76)
- Hampton Plaza Shopping Center. The marked entrance and exit lanes, and the marked aisles in the parking lot of the shopping center which is commonly known as the Hampton Plaza, which is located in the southeast quadrant of the intersections of Rochester Road and Hamlin Road. This area shall specifically include the area adjoining the buildings in the Hampton Plaza Shopping Center, extending from the curbs in front of said buildings to the area marked for parking spaces.
