CHAPTER 7-04

DISORDERLY CONDUCT ON SCHOOL PROPERTY

7-04.01 <u>Purpose</u>

Loitering, disturbances, or damaging property in public, private, and parochial schools or on public, private, or parochial school sites in the City of Rochester Hills shall be prohibited. (Amended by Ordinance No. 339, effective May 7, 1993)

7-04.02 Acts Prohibited

- .01 Destruction of Property. No person shall damage, destroy or deface any public, private or parochial school building, or any building occupied by any public, private or parochial school, or the grounds, out-buildings, fences, trees or other appurtenances or fixtures belonging thereto.
- .02 Disturbing the Peace. No person shall wilfully or maliciously make, or assist in making any noise, disturbances or improper diversion, by which the peace, quietude or good order of any public, private or parochial school is disturbed.
- .03 Immoral Language or Conduct. No person shall use profane, indecent or immoral language or indulge in indecent or immoral conduct in any building or on any property adjacent to any building in the City occupied as a public, private or parochial school.
- Loitering in School Building. No person who is not a regularly enrolled student, teacher, parent or other employee, school supply salesman or any person engaged in legitimate school business or pursuits or one who is attending regularly scheduled meetings or programs, shall enter and remain in any school building, whether public, private or parochial, in the City, for any reason whatever unless such person has received written permission from the principal, or other person designated by the principal, to be in any such public, private or parochial school building.
- .05 Borrowing. It shall be unlawful for any person to borrow or attempt to borrow any money or thing of value from any student in any public, private or parochial school or on any public, private or parochial school property in the City or during any time when any such student is going to

or returning from any regularly scheduled session of any such school without first obtaining the written approval of the principal of such school or other person designated by the principal to issue such written approval.

.06 Trespassing. No person shall trespass upon any public, private, or parochial school site which has been registered with the City in accordance with Chapter 7-02 of this Code. Except as provided in Chapter 7-02, no person shall be present upon any school site during a time when school is not in session; provided, however, that a person may utilize recreational facilities located on a school site during posted hours. (Added by Ordinance No. 339, effective May 7, 1993)

7-04.03 Immediate Expulsion

Any person found to be creating a disturbance in any private, public, or parochial school or on the surrounding school grounds shall leave immediately when so directed by the principal or by any other person designated by the principal.

7-04.04 Enforcement

The law enforcement agencies of the City of Rochester Hills, which includes the Oakland County Sheriff's Department, shall have the right and authority to enter upon any public, private, or parochial school site for the purpose of enforcing this Chapter. (Added by Ordinance No. 339, effective May 7, 1993)
